Transit System Elements

- Local Bus
 - Mainline Service
 - Local and Feeder Routes
 - Paratransit (ADA)
- Premium Services
 - Bus Rapid Transit and/or Light Rail
- Regional
 - Express Routes
 - Commuter Rail (Peak Services)
 - Park-n-Ride
- Circulators
- Niche Services
- Hubs and Transfer Stations



JTA Transit System

- Over 42,000 passenger trips / day
- 29 Local Bus Routes
- 6 Express Routes
- 8 Community Shuttles
- 2 Trolleys
- Connexion (Paratransit Service)
- Skyway
- Over 160 Buses
- 3 Hubs (Rosa Parks, Gateway and Regency)
- 7 Park-n-Ride facilities



Path to World Class Transit System

- Improve Local Service First
 - Reliability: On-Time Transit Operations (OTTO)
 - Effectiveness: Route Optimization Initiative (ROI)
 - Efficiency: CNG Conversion
 - Customer Service and Amenities: Shelters and Stops, Real-Time Passenger Information and Mobile Ticketing
- Premium Service: First Coast Flyer
- Skyway Future
- Regional Transit
 - Regional Transportation Commission
 - Park and Ride and Regional Express
 - Commuter Rail





Route Optimization Initiative

- Complete route restructure implemented
 December 2014
- Focus on making routes more frequent, direct and reliable
- Extended hours of service at night
- Added weekend service hours
- 80+ mile frequent network created
- Route miles with 30 minute or better serve quadrupled





Route Optimization Initiative

	Pre-ROI	ROI
Downtown Circulation	Most routes run all over downtown	Fewer routes offering 5-10 minute service to all parts of downtown
Frequent Routes (15 Min)	None	10 routes60% of current riders within ¼ mile
30 Min Frequency	Two routes	 20 routes 90% of current riders within ¼ mile
Stop Spacing	Too close – often every block	Consistent spacing (1/8 mile standard in urban area)
Route Names	Inconsistent and difficult to understand (e.g. L9, CT1, WS2)	Simple numbering system (industry standard)
Span of Service	11 routes run past 11 p.m.3 routes run after midnight	 22 Routes run after 11 p.m. 16 routes run after midnight
Weekends	1 route every 30 min. Saturday	10 routes every 30 min. Sat & Sun
Supervision	Zonal Management	End-to-end route accountability

First Coast Flyer Status

- Downtown Enhancements
 - Under construction
- North Corridor (Green Line)
 - Fully funded, under construction, and service begins Dec. 7
- Southeast
 - Fully funded with Service planned for December 2016
- East and Southwest
 - Approved into project development by FTA and seeking FTA
 New Starts funding



Jacksonville Regional Transportation Center (JRTC)

Multimodal Transfer Facility

- Local Services
 - First Coast Flyer and Local Bus
 - Skyway
 - Other: Bike and Car Sharing, Taxi, Park-n-Ride
- Regional Services
 - Express Bus and Future Commuter Rail
- Intercity Services
 - Bus: Greyhound, Megabus
 - Rail: Amtrak, All Aboard Florida













Jacksonville Regional Transportation Center (JRTC)





Commuter Rail

- Operates within existing freight rail right-of-way
- Typically peak hour and midday service
- Less frequent and fewer stops than light rail
- Three lines identified and prioritized in Commuter Rail System Plan:
 - 1. Southeast from Jacksonville to St. Augustine
 - Southwest from Jacksonville to Green Cove Springs
 - 3. North from Jacksonville to Yulee
- Conducting work to position Southeast Corridor for federal funding

Key Considerations

- The Skyway is part of the larger transit system and future vision for a world class regional transit system
- Effective transit systems depend on a strong downtown
- Strong downtowns need effective public transportation
- Cities are America's economic engines
- Growing urban areas need transportation choices to support growth, quality of life and economic vitality
- Vibrant cities with effective public transit are important to attracting young talent (e.g. millennials)
- Skyway discussion is about the future vision of downtown, AND a vision for world class regional transportation system
